Purpose of Consultancy	In the past few years, the United Nations Population Fund (UNFPA) has been increasingly recognized as the UN lead agency in the area of programming for young people and particularly most marginalized youth. Within the framework of programming for young people, UNFPA has supported a number of behavior change communication initiatives, including peer education initiatives in general and theater based peer education in particular.	
	Edutainment strategies, as any communication strategy for social change, face diverse challenges; nevertheless, accumulated experiences from around the world show the effectiveness of this approach. In its work, UNFPA through its Y-PEER initiative became recognized for combining different strategies: a knowledge management system ("what" and "how to") with popular mass media and local media appeal, with on-going coverage and enabling benefits of television and radio shows; theater-based peer education; community mobilization and coordination alliances with local organizations; social networking; use of new technologies, including educational videogames and phone applications; training activities, interpersonal reinforcement mechanisms, as well as advocacy to change laws and policies; links with service delivery; ongoing monitoring and evaluation, and dissemination of results.	
	A number of global research papers strongly suggest that peer-led theatre presented in conjunction with peer-led discussion has the potential to not only engage young people but to also increase self-reported confidence in their ability to reduce risky behaviors.	
	In 2019, UNFPA supported an assessment of Theatre-Based Techniques utilized by Y-Peer and other NGOs. The assessment concluded that there is lack of experience and knowledge by most actors on how to respond to audience interventions while remaining in character. The assessment also concluded that there is a need to provide Y-PEER theatre groups with more training in acting skills, primarily in "actors in role" technique and facilitating techniques in order to build their capacities to reach a better standard of performance and facilitation and have a better impact.	
	Accordingly, the UNFPA Egypt Country Office will recruit an international consultant to conduct an advanced facilitation training for actors/ educators of theater-based education that is used it its programs
