Purpose of consultancy:	Develop the contents for different types of Information, Education and Communication (IEC) materials about youth friendly health services (YFHS).	
Scope of work: (Description of services, activities, or outputs)	Egypt is a young country with around 60% of the Egyptian population is under the age of 29 and 40% is between the ages of 10 and 29 (census 2017). Egyptian adolescents and youth face a magnitude of challenges in acquiring information and services related to obtaining RH knowledge and care from reliable sources that empower them to achieve a safe transition from childhood to adulthood as well adopt healthy behaviours.	
	Youth friendly clinics (YFCs) affiliated to the school-age directorate, Primary health Care (PHC) Sector/MoHP, is one approach to provide the young people with information, counselling and clinical services to promote youth health and preventing risky health behaviours and problems, and referral to other health services, when necessary. UNFPA has been supporting the YFCs on many levels including capacity building training for the service providers and equipping the clinics with medical and non-medical requirements. It's suggested to develop different types of IEC materials as mentioned below that are appealing to the young people.	
	Therefore, UNFPA is looking for a qualified consultant to develop the contents of the six hand booklets as IEC materials to convey health messages about RH/ FP and available services. The booklets will be as follows:	
	- Youth friendly clinics and relevant services;	
	- Health topics for adolescent girls below 16 years old;	
	- Health topics for adolescent girls above 16 years old;	
	- Health topics for adolescent boys below 16 years old;	
	- Health topics for adolescent boys above 16 years old;	
	- A guide for caregivers (parents, teachers, social workers, etc).	
	These booklets are to be developed in a manner that is gender-sensitive and age-appropriate.
