Purpose of consultancy:	<p>The overall purpose of the consultancy is to conduct a performance assessment of the ongoing 65 Reproductive Health and Family Planning clinics of Ministry of Social Solidarity</p> <p>Within the framework of the project between Ministry of Social Solidarity and UNFPA, the project aims to expand the already existing 65 clinics and establish 120 new clinics, providing reproductive health care services and family planning services within poverty alleviation programmes through targeting the beneficiaries of mainly Takafol & Karama Programme in governorates through expanding service delivery channels via CSOs.</p> <p>In this context, there is a need to assess the performance of the already existing clinics in the 11 governorates (Assiut, Aswan, Behera, Beni Suef, Cairo (Al Asmarat), Fayoum, Giza, Luxor, Minya, Qena, Sohag) before expanding and establish new clinics.</p>
Scope of work: <i>(Description of services, activities, or outputs)</i>	<p>The consultant is expected to complete the assessment using various tools and methods that measure the quality and effectiveness of the services provided.</p> <p>The specific objectives of the assessment are :</p> <ol style="list-style-type: none"> 1. Assess the roles and responsibilities of the clinics in providing comprehensive reproductive health care services including the role of service providers, role of counselors ,client registration system , information, education, and communication materials and equipping 2. Describe the readiness and lessons learned before expanding in other governorates. 3. Evaluate client satisfaction in the geographical area served by the clinics 4. Review and agree on survey proposed methodology, work plan and the structure of the survey report with project team 5. Outline the assessment design and develop data collection tools, using both qualitative and quantitative data tools. 6. Conduct and supervise data collection, data management, and data analysis 7. Identify the required sample for the interviews. 8. Preparation of draft report 9. Discuss with the project team the findings of the initial draft report 10. Incorporate the feedback from the project team in the final report 11. Make a presentation on the key findings of the assessment in Arabic. 12. Submit hard and soft copies of the final report, both in English and Arabic, and key findings presentation 13. Develop a policy paper addressing findings and recommendations 14. Set recommendation for scaling up of comprehensive reproductive health care services at other governorates.
